### **Trading Standards Campaign and Safeguarding resources**

The National Trading Standards Scams Team are proud to launch our new 'No Blame. No Shame.' Campaign. This campaign is following the *Coercive Control in Fraud, Scams and Financial Abuse: Learning from Domestic Abuse* research <u>report</u> which launched earlier this year. The team have produced a video to explain what coercive control is and how it is used in fraud, scams and financial abuse setting, and to raise awareness. There are asks at the end of the video to talk about and recognise the impact of coercive control in fraud, scams and financial abuse, and to change the language we use around victims of this crime.

The aim of this campaign is to take away the blame and shame from the victim and instead, put the blame back on the criminal where it belongs.

- Free door cameras (for those susceptible to in person crime on the doorstep)
- Free sticker packs (Scams, No Cold Calling, Pre-shopping legal advice translated into easy read format)
- Illegal Money Lending (avoiding loan sharks)
- Scams and Fraud (prevention and protection messaging).

#### Launch of sexual safety charter in healthcare organisational charter

We are pleased to share that today, NHS England launched its first-ever sexual safety charter in collaboration with key partners across the healthcare system. Signatories to this charter commit to taking and enforcing a zero-tolerance approach to any unwanted, inappropriate and/or harmful sexual behaviours within the workplace, and to ten core principles and actions to help achieve this. It is expected that signatories will implement all ten commitments by July 2024.

### Online Safety Bill Update

The NSPCC has published an article on the passing of the Online Safety Bill through Parliament. The legislation will require technology companies to ensure their websites are safe for children and protect them from sexual abuse and harmful material. #### Working Together to Safeguard Children updated December 2023

The DfE published an updated version of Working Together on 15 December 2023.

#### Working together to safeguard children 2023

This revision to the guidance focuses on strengthening multi-agency working across the whole system of help, support and protection for children and their families, keeping a child-centred approach while bringing a whole-family focus, and embedding strong, effective and consistent multi-agency child protection practice.

#### The update includes:

- principles for working with parents and carers that centre the importance of building positive, trusting and co-operative relationships to deliver tailored support to families.
- expectations for multi-agency working that apply to all individuals, agencies and organisations working with children and their families, across a range of roles and activities.
- new national multi-agency child protection standards that set out actions, considerations and behaviours for improved child protection practice and better outcomes for children.
